Business Need

- Client was seeking to outsource Application Development and Maintenance (ADM) work with the objective to drive down costs, through increased use of resources and services delivered from lower cost (offshore) locations, while maintaining existing capabilities
- The IT applications identified to be included within the scope of the initiative were currently supported by Client's internal employees and contractors for application maintenance and development activities – a portion of these FTEs were suitable for outsourcing and offshoring
