Client Situation:

The client had multiple products in risk management, sales & marketing, e-business and supply chain management. All these products were independent, based on different platforms, making them difficult and expensive to maintain and support. The client had also acquired a credit risk company and wanted to integrate the acquired company's offerings with their own. In addition, the existing products were based on a transactional model where the clients have to pay for every report pulled, resulting in limited usage by the customers.

Our solution:

After a careful analysis of the client situation, we designed and delivered a single global portal platform to deliver all strategic products under a single web-based framework. The solution followed a subscription model rather than a transactional model, where the customer can pay an annual subscription fee and pull unlimited number of reports rather than pay for every report pulled.
