Claims Data Manager includes online editing capabilities for claims that your plan needs to resubmit.

TriZetto® Risk Score Manager calculates risk scores utilizing CMS methodology and projects revenues for Medicare Part C and Part D. It analyzes data submitted by Claims Data Manager and Encounter Data Manager to calculate potential risk score reimbursement based on the diagnoses submitted to CMS and reconciles RAPS and Encounter Data Processing System submissions to improve the accuracy of data.

TriZetto® Risk Adjustment Manager identifies and collects risk adjustment data to support your plan's ability to increase revenue accuracy. By aggregating claims, pharmacy and demographic data, Risk Adjustment Manager uses proprietary algorithms to identify members with potential hierarchical condition category suspects. It captures chart review results and provides actionable information on chart selection to generate files for submission to CMS. Risk Adjustment Manager also provides a Prospective Evaluation Tool that assesses members' health prior to claims submission.

TriZetto® Risk Adjustment Manager for Exchanges aggregates patient data and identifies clinical suspects for risk review, coding resolution and formatting prior to CMS EDGE server submission. Indications of inaccurate or unspecified patient conditions can be recognized and addressed quickly by applying Milliman's IMPROVE advanced algorithms against claims, pharmacy data, and patient and care delivery demographics.

automates the workflow associated with CMS Prescription Drug Event submissions. The application imports PDE return files from CMS and the Drug Data Processing System, identifies issues, determines the reasons for rejection or acceptance, and provides the ability to correct them for resubmission to CMS. Prescription Drug Event Manager also provides peer-to-peer accounts receivable management reporting.
