Setup required features



What's changing

With the 2024R2 release, Workday improves Alternate Ledger Currency (ALC) and now enables you to configure custom validations on ALC journals, providing added flexibility in validating journals.

Additional considerations

Workday now supports your custom validations on ALC journals.

If you have custom validations on ledger or total ledger debits and credits, you must:

- Modify the existing validations to cover both alternate and primary ledger currency.
- Create respective alternate ledger currency related custom validations.

Workday also deliver a new Primary Ledger Journal report field (secured to the Public Reporting Items domain) on these business objects that you can use to identify if the journal or journal lines are for primary ledger journals:

- Journal Entry
- Journal Line





Supplemental schedules

S

What's changing

With 2024 R2, Workday delivers Supplemental Schedules that enable you to create quantitative supplemental data schedules for footnotes, disclosures, and supporting details for external reporting purposes.

Types of supplemental schedules you can bring into Workday include:

- Aging schedules
- Balance sheet roll-forwards
- Future commitment schedules

Note: Supplemental Schedules utilizes Worksheets, a spreadsheet based component in Workday that enables ad hoc data exploration, analysis, visualization, and collaboration with live transactional data.

Security Domains:

With this update, we deliver these new domains secured to the Advanced Close and Consolidation functional area:

 Setup: Supplemental Data: Use this domain to secure access to create, maintain and view supplemental data templates and supplemental data text lists.

What do i need to do?

Configure these security domains:

- Setup: Supplemental Data.
- Process: Supplemental Data.
- Process: Consolidated Supplemental Data.
- Process: Translated Supplemental Data.
- Worksheets: To grant access to enter supplemental data in a workbook.

Create Supplemental Data Templates

Create templates to share across all your subsidiaries to ensure a standardized and consistent supplemental data collection process.

Access the Create Supplemental Data Template task from the Supplemental Data Hub report.

Additional considerations (cont.)

- Process: Supplemental Data: Use this domain to secure access to create and view supplemental data.
- Process: Consolidated Supplemental Data: Use this domain to secure access to create and view consolidated supplemental data.
- Process: Translated Supplemental Data: Use this domain to secure access to maintain and view supplemental data translation amounts.

Supplemental Data Hub:

Workday delivers a new Supplemental Data Hub report (secured to the Process: Supplemental Data domain) that you can use to track the status of supplemental data and consolidated supplemental data and take necessary actions.

Supplemental Data Template Tasks:

Workday delivers these new tasks (secured to the Setup: Supplemental Data domain) that you can use to create and maintain supplemental data templates:

- Select the Fiscal Schedule you want as the shared fiscal schedule for your reporting hierarchy.
- When you configure at least 1 Currency data type on a template, the Default Account Translation Account Method field displays and is required.
- (Optional) Enable Roll Forward to define additional template configurations when creating a balance sheet roll forward type of schedule.
- On the Column section, create columns that are associated with a delivered Data Type.

They deliver a new **Supplemental Data Search** task (secured to the Process: Supplemental Data domain) that you can access from the **Supplemental Data Hub** report. Use the task to search for supplemental data.

Workday also deliver a new **Maintain Supplemental Data Attachments** task (secured to the Process: Supplemental Data domain) that you use to create and maintain attachments on supplemental data.

Maintain Supplemental Data Translation Amounts Task:

Workday delivers a new Maintain Supplemental Data Translation Amounts task (secured to the Process: Translated Supplemental Data domain) that you can access from the related actions menu of the supplemental data. Use the task to view and override the system generated translated amounts, such as due to rounding, or to load translated beginning balances values for Roll Forward type supplemental schedules.

What do i need to do? (cont.)

Security: Setup: Supplemental Data in the Advanced Close and Consolidation functional area.

(Optional) Create Calculated Fields

- Create an arithmetic expression to calculate the value for a column to streamline the data entry process.
- After you create Calculated Fields on the Supplemental Data Row business object, you can associate them to a column configured as a Numeric or Currency data type under Properties when you configure the Supplemental Data template.

Note: You must create a calculated field when you create a Supplemental Data Type Template with a Roll Forward configuration.

Security: Custom Field Management domain in the System functional area. (Optional) Maintain Supplemental Data Templates

 Use this task to manage your Supplemental Data templates and deactivate any templates that you no longer need or aren't using in any active scheduled future process. This task also provides additional information about in-progress and approved supplemental data from a template.

Additional considerations (cont.)

Consolidated Supplemental Data Tasks:

Workday also delivers these new tasks (secured to the Process: Consolidated Supplemental Data domain) that you can use to create and maintain consolidated supplemental data for a given template in a workbook:

- Cancel Consolidated Supplemental Data. You can access the task from the related actions menu of the consolidated supplemental data.
- Create Consolidated Supplemental Data.
- Consolidated Supplemental Data Hub & Consolidated Supplemental Data Search. You can access the task from the Consolidated Supplemental Data tab of the Supplemental Data Hub that you use to search and track the status of consolidated supplemental data.
- Copy Consolidated Supplemental Data. You can access the task from the related actions menu of the consolidated supplemental data.

Roll Forward Supplemental Data Task:

Workday delivers a new **Roll Forward Supplemental Data** task (secured to the Process: Supplemental Data domain) that you can access from the related actions menu of the supplemental data from a Supplemental Data Template with Roll Forward configuration. Use the task to roll forward supplemental data.

What do i need to do? (cont.)

Security: Setup: Supplemental Data security domain in the Advanced Close and Consolidation functional area.

Configure Business Processes

Configure these business processes to approve or deny and submit the creation of Detailed Supplemental Data:

- Detailed Supplemental Data Event
- Consolidated Supplemental Data Event

(Optional) Create Custom Validations

 Access the Maintain Custom Validations report to create critical custom validations for supplemental data. This ensures consistency and accuracy of data entry prior to submission for business process approval.

Security: Set Up: Custom Validations domain in the Common Financial Management functional area.

Mass Roll Forward Supplemental Data Task:

Workday also delivers a new **Mass Roll Forward Supplemental Data** task (secured to the Process: Supplemental Data domain) that you can use to roll forward multiple Supplemental Data workbooks.

Note: To roll forward multiple Supplemental Data workbooks, you must use the Supplemental Data Template with Roll Forward configured.

Mass Generate Supplemental Data Tasks:

Workday delivers these new tasks (secured to the Process: Consolidated Supplemental Data & Process: Supplemental Data domains) that enable you to mass generate supplemental data and supplemental data job statuses:

- Mass Generate Supplemental Data
- Mass Generate Supplemental Data Job Status

Business Processes:

Workday has added these new business processes (secured to the Advanced Close and Consolidation functional area) that you can configure to route detailed supplemental and consolidated supplemental schedules for approval:

Report Fields:

Workday delivers 27 report fields on the new Detailed Supplemental Data business object (secured to the Public Items Reporting domain).

They also deliver 239 report fields on the new Supplemental Data Row business object (secured to the Public Items Reporting domain).

They deliver 17 report fields on the new Supplemental Header business object (secured to the Public Items Reporting domain).

Create and Submit Supplemental Data

- Access the Create Supplemental Data task from the Supplemental Data Hub.
- Select 1 of the predefined Supplemental Data templates to generate a workbook that you can use to enter supplemental data.

Create Custom Reports

 Create an Advanced or a Matrix report from the Supplemental Data Row data source to use Live Data Capabilities within Worksheets. The report returns Supplemental Data Rows translated into a common reporting currency in a single reporting view.

Security: Process: Consolidated Supplemental Data domain in the Advanced Close and Consolidation functional area.

(Optional) Mass Generate Supplemental Schedules

 Access the Mass Generate Supplemental Data task from the Supplemental Data Hub to create multiple Supplemental Data and Consolidated Supplemental Data workbooks for the current or future periods.


