Hosting costs may include but are not limited to Microsoft Azure, any third-party license obligations, support labor and implementation. The TriZetto Interoperability Adapter will also be delivered with new purchases of the Facets Open Access or the QNXT QXI platform.

Clients with previous versions of the Facets and QNXT platforms may need to upgrade to the latest version to take advantage of all-new capabilities, including the Interoperability Adapter. Otherwise, Cognizant Services can develop custom API feeds and integrate other data sources to enable data standardization and translation.
