Seamlessly connect site and sponsor systems for enhanced collaboration

Conducting effective clinical trials depends on seamless and continuous exchange of records, documents and data between sponsor study teams and research sites. This exchange requires clinical research site staff to update and maintain numerous key documents, data management systems and site information throughout a clinical trial, including CVs, FDA Form 1572 and users' training records and safety notifications, among others. While many research sites, including large academic medical centers and mid-size organizations, have invested in their own systems to manage their records, they must also manage and track all the records and documents to be exchanged with their various sponsors. In many instances, the documentation provided by clinical study sites is the same from sponsor to sponsor and requires site staff to upload and send the same records and documents to multiple sponsors.

Sponsors, on the other hand, use many different systems and portals when conducting clinical trials. These systems and portals require sites to electronically upload documents and populate various sponsor systems with significant amounts of data. Even when sites have digital platforms to manage their clinical trial records and documents, each site must still regularly manage multiple digital uploads and record transfers to multiple sponsor systems. With no single pathway or link between site and sponsor systems, the task of managing the continuous transfer and exchange of clinical trial data and records is time consuming and complicated.

Challenges

Both sites and sponsors face similar challenges when attempting to share and streamline the exchange of documents, records and data for clinical studies:

- Given the plethora of clinical study sites sponsors must work with, integrating site systems on an enterprise scale is costly and time-consuming
- The same thing holds true for clinical trial sites—daily and continuous efforts to connect with multiple sponsor systems and assure accurate and complete uploads of a sites' records, documents and data is a time-consuming struggle



Solution

Cognizant® Clinical Systems Connector (the “Connector”) is designed to help address these challenges. By leveraging standard REST APIs, the Connector acts as an integration hub that allows the seamless and bi-directional exchange of records, data and documents from site systems to sponsor systems, and vice versa.
