Agile, scalable, streamlined investment operations on AWS

The challenge

A European pension company, with more than 300,000 customers, required a solvency platform to ensure the availability of pension assets. As part of an as-a-service initiative, the pension client needed an agile, scalable platform with intent-based automation of workloads, and separation from existing infrastructure for improved solvency assurance in a secure environment as well as low capital expenditures and operating costs.

The approach

We began by conducting a detailed workshop with the client to understand the requirements and design for the new platform. We developed a cloud deployment architecture and design for the HPC application as well as a total cost of ownership comparison between on premises and cloud workloads.

Next, Cognizant engineered an HPC solvency platform on AWS Cloud with custom-built, intentbased provisioning capabilities and secure integration into existing pipeline as well as existing AWS landscape. The HPC solution was deployed in AWS cloud on a dedicated VPC to provide isolation from other servers while dependent services like file share, active directory, monitoring, and antivirus were provisioned from shared services.

A key solution feature of the solution is the cross-platform monitoring system. This system, deployed as a single interface, shows state, health, and performance information of loads in the platform. The HPC servers are domain joined and specific users are assigned access as needed. The HPC generates accurate and timely analytics for solvency assurance.

Our customer now has a scalable and highly secure platform providing both analytics requirements and traceability. The new HPC solvency platform fits into the client's existing AWS landscape. Autoscaling capability provides complete traceability from task request and deployment, through deprovisioning.

Users can now initiate a request for new servers or additional servers to provision compute nodes in AWS. Compute capacity is now on-demand. When needed, additional computing power for the HPC platform will be assigned. Upon task completion, the servers on AWS will terminate automatically.
