Founded in 2015 by Cognizant, New People, and Lubbers de Jong, the Digital Transformer Awards (DTA) celebrated individuals and organizations driving digital innovation. Notable highlights include Hans Böhm (former Managing Director of Beerwulf and Heineken) receiving the award in 2018, and a distinguished 2019 jury featuring Tjalling Smit (CCO of NS) and Henk Volberda (Professor of Strategic Management & Innovation at UvA).

After a long hiatus, we're excited to relaunch the program in 2025 with fresh partnerships and a renewed focus on data and Al. Introducing the Data Transformer Awards—a platform to spotlight the most impactful data-driven leaders and solutions in the Netherlands.

### Round 1: Best Project / Use Case (Focus on Output)

| Methodology          | What innovative methodologies have you implemented in your data and AI projects, and how have they led to successful outcomes?   |

| Collaboration        | How do you foster collaboration within your team and with external partners, and can you share a specific instance where this significantly improved a project?                                |
| Value                | How have your data and AI initiatives created value for your organization or clients, and can you quantify the impact in terms of revenue, cost savings, or other metrics?                     |
| Readiness            | How prepared is your organization to implement and scale data and AI solutions, and can you provide examples of how you have addressed readiness issues in past projects?                      |
| Change<br>Management | How do you manage change within your organization when implementing new data and AI solutions, and can you share a case where effective change management led to a successful project outcome? |
| Modernisation        | How have you modernized your data infrastructure and processes, and can you provide examples of how modernization has improved your operations?  |
| Regulation           | How do you ensure compliance with data protection and privacy regulations in your projects, and can you share an example of how you navigated regulatory challenges?                           |

| Speed of<br>Adoption      | How quickly and effectively has your project been adopted by users, and what strategies did you employ to facilitate this adoption?                     |

## Nomination Process for the Data Transformer Awards (DTA)

Candidates can nominate themselves or be nominated by others via the website: <a href="https://www.data-transformers.nl/nomineren.html">https://www.data-transformers.nl/nomineren.html</a>. Submissions are open from 22 May to 25 September 2025. After 25 September, no further applications will be accepted.

### **Submission Requirements:**

#### **Self-nominations must include:**

- A description of the data transformation
- The intended outcome
- A motivation statement
- · A brief summary for the initial selection round

#### **Third-party nominations must include:**

- A short explanation of why the candidate is eligible
- The DTA team will contact the nominee directly to request additional details

Please ensure all information is accurate before submitting. Once the "Nominate" button is clicked, changes cannot be made.

#### **Selection Process:**

- An independent jury will evaluate all entries using Round 1 criteria to select nominees.
- A shortlist of three finalists per category will be invited to pitch their case on Friday, 24 October 2025.
- Finalists will be announced on Friday, 7 November 2025.
- Winners will be revealed at the award ceremony on Thursday, 13 November 2025.
